



Once you have checked the general information about <u>applying to master's programmes in the UK</u> it is time to revise carefully the specific information and <u>requirements for programmes</u> in your preferred subject.

With the aim of helping you with this decision-making process, we prepared this report containing key information about application requirements, acceptance rates, and English proficiency tests required to get accepted in your dreamed programme. We hope this information will complement the general advice given in our guide on applying to master's programmes in the UK, and will help you to make this important choice to develop your career successfully.

English Proficiency

If you want to study in the UK you need to prove your <u>excellent English level</u>. You have different options to do it:

- You are from a majority English speaking country
- Your previous education was in a majority English speaking country
- You have an accepted test in English language (not older than 2 years) at a level specified for your future university
- You take an English language pre-sessional course at your future university
- You have worked a minimum of eighteen months in a majority English speaking country

For most of the applicants an official English test is a must do, and along with it comes preparation time to meet expectations and scores established by universities. If you are interested in getting an overview of requirements for all disciplines plus the expected scores per modules please visit our report about general information to apply to a master's programmes in the UK.

Thinking about your potential concerns regarding scoring enough to match the application requirements of your preferred programme, we have prepared the following table with an overview of the typical minimum scores from the English tests most commonly accepted by universities to study Master's programmes in economics, finance, accounting, marketing and/or related disciplines. Not all universities accept all tests; therefore it is always advisable to visit the website of the university for detailed information.

Application Overview

Finally, to make easier the collection of documents for your application, here you can find the most common requirements for Master's programmes in economics, finance, accounting, marketing and related subjects. The following list is just an overview; for specific programmes we recommend you check the requirements of individual institutions.

General documents:

- An academic transcript
- References
- A personal statement
- A certificate of English language proficiency

Additionally you need for:

Economics:

- A bachelor's (honours) degree or equivalent in economics or a relevant quantitative subject
- GRE or other graduate entrance scores
- A certificate of English language proficiency

Finance and Accounting:

- A first degree (at least upper second class honours or equivalent) in finance, accounting, economics, business, mathematics or a relevant quantitative subject
- GMAT scores, particularly for applicants with non-EU first degrees

Marketing:

- A first degree (at least upper second class honours or equivalent) with significant content in business, management and marketing
- Work experience in marketing



Methodology
